### **Updates from the Workgroups**

#### Education Workgroup

Brandy Martinez has resigned her position as Co-chair due to workload balance but will continue to maintain participation with this workgroup. #### Data Workgroup

**Group Lead: Brett Dodwell –** <u>brett.dodwell@memorialhermann.org</u> – The Data Workgroup's 'First Friday' monthly meeting was conducted on 7/1/2022 from 0930 to 1000. Our standing invitation to attend the 30-minute meetings continues, with our next meeting set for Friday 8/5/2022. Please contact Christine Reeves or Brett Dodwell for meeting invites and info.

The workgroup leadership has shifted into a higher gear, and as meeting times are limited, the typical historical review of goals will not be routine so that more forward efficient work can be produced. The workgroup continues to enjoy the marked increase in attendance and values all attendee's input.

The collaborative team of state epidemiology, DSHS, and workgroup leadership last met on 7/22/2022 where the primary points of discussion centered on the recently released 2021 state registry tourniquet data; its comparison to the 2020 data; and its differentiation to RAC data. Modalities and granular data will be compared between RACs 'Q' & 'I' and the state registry as we continue to develop a best guideline for harvesting tourniquet data at the state level. Discussion also involved the operational deployment of NEMSIS v3.5 and the perspective of 'pre-hospital' tourniquet data. GETAC Trauma will be informed on developments at the August 2022 meeting.

The workgroup continues development on the 'How To' tourniquet abstraction guideline document and encourages all interested members to provide input from the EMS, Hospital, Regional, and State perspectives.

The RAC Data Collaborative was conversed in relation to prospective tracks for tourniquet data harvesting, with Ms. Helgeson agreeing to begin a discovery.

The workgroup leadership continues to value all stakeholder participation and would like to highlight Jia Benno, Nadia Bekka, and Indra Hernandez with DSHS for their support and initiative.

# **HYBRID TRAINING ACROSS THE STATE**

We want as many RACs, Trauma Centers, EMS Agencies across Texas to host Stop the Bleed Trainings throughout the month of May. Be sure to provide that information to your RAC or the Stop the Bleed POC at your RAC.



We completed five of these hybrid courses on May 19, 2022, for National Stop the Bleed Day. We were able to train 45 persons that would not have been taught otherwise.

The Coalition used these codes for Stop the Bleed Day activities. Many of the RACs used them. Thanks to those that did. It allows us to capture more Texas specific data. The Coalition will be deciding on this format at our upcoming meeting – August 12<sup>th</sup> at 1000. The Coalition will share full results at that meeting but here are some teasers.

- STB Month 602 participants took part in STB training & this survey.
- Hidalgo County had the most participants at 104. Great Job!
- 42.29% were male and 56.88% were female and 1.49% preferred not to answer.
- Ages were similar percentages.
- 89.02% took the course in person. 4.9 stars was the average rating.
- 275 response provided more positive comments at the end.
- 100% of participants would recommend to others!!!!!!!!!
